

Privacy Notice

This privacy notice discloses the privacy practices for whiskeyfortheages.com. This privacy notice applies solely to information collected by this website. It will serve to notify visitors to the website of the following:

- What personally identifiable information is collected from visitors through the website, how it is used and with whom it may be shared.
- What choices are available to visitors regarding the use of their data.
- The security procedures in place to protect the misuse of visitor information.
- How visitors can correct any inaccuracies in the information collected.

Information Collection, Use, and Sharing

We (administrators of whiskeyfortheages.com) are the sole owners of the information collected on this site. We only have access to collect information visitors voluntarily give us via email or from other direct contact. We will not sell or rent this information to anyone or any entity.

We will use contact information to respond regarding the reason the correspondent contacted us. We will not share visitor information with any third party outside of our organization, other than as necessary to fulfill a correspondent's request (e.g. to ship an order).

Unless specifically asked not to, we may send information via email in the future to tell registered visitors about specials, new products or services, or changes to this privacy policy.

Registration

On occasion and in order to use this website, a user may be first asked to complete a registration form. During registration a user is required to give certain information (such as name and email address).
